1. Introduction

More Opportunity ("we," "our," or "us") uses cookies and similar tracking technologies on our website <u>www.moreopportunity.net</u> ("Website") to enhance user experience, analyze website traffic, and provide relevant content. This Cookie Statement explains what cookies are, how we use them, and how you can manage your cookie preferences.

2. What Are Cookies?

Cookies are small text files that are stored on your device (computer, tablet, or smartphone) when you visit a website. They help websites function properly and improve the user experience by remembering preferences, enabling secure logins, and collecting statistical data.

There are different types of cookies:

- First-party Cookies: Cookies set by the website you are visiting.
- **Third-party Cookies:** Cookies set by external services used on our website (e.g., analytics, advertising).

3. What Cookies Do We Use?

More Opportunity uses the following categories of cookies:

3.1 Essential Cookies (Strictly Necessary)

These cookies are required for the basic operation of our website. They allow you to navigate the website, use essential features, and maintain security. Without these cookies, the website may not function properly.

- Example: Authentication cookies for login sessions.
- Legal Basis: Legitimate Interest (GDPR Article 6.1(f))

3.2 Functional Cookies

These cookies enable the website to remember user preferences, such as language settings or previously visited pages, for an improved browsing experience.

- Example: Saving your location preferences.
- Legal Basis: User Consent (GDPR Article 6.1(a))

3.3 Analytical & Performance Cookies

We use these cookies to collect anonymous data about how visitors use our website. This helps us analyze traffic, identify popular pages, and improve website performance.

- Example: Google Analytics, Matomo, or similar services.
- Legal Basis: User Consent (GDPR Article 6.1(a))

3.4 Marketing & Advertising Cookies

These cookies track your online activity to display relevant ads and personalized content. They may be set by third-party advertising services such as Google Ads or social media platforms.

- Example: Facebook Pixel, LinkedIn Ads, Google Ads Retargeting.
- Legal Basis: User Consent (GDPR Article 6.1(a))

4. Third-Party Cookies

Some cookies on our website are placed by third-party services, which may collect data independently. We recommend reviewing their privacy policies:
